Message from the Board Chair and Chief Executive Officer

Mind is known for innovative services and high standards of service delivery. Our deeply experienced and skilled staff provide people with enduring and severe mental illness the psychosocial support they need to achieve better mental health and improved quality of life.

We thank our staff for their unwavering commitment. Mind has made a strong commitment to the existing workforce and the role that they play.

The NDIS is one of the largest reforms in Australia's history and represents a major shift for people with mental health related disability and the providers that support them. Ensuring it recognises and meets their needs is foundational to what we in turn are able to achieve.

Mind is one of over 100 signatories to Charter 2020, a key set of agreed principles the sector has declared as crucial to improving Australia's mental health system. This has been developed in recognition of the once in a lifetime opportunity for reform presented by the federal government's Productivity Commission Inquiry into Mental Health and the Royal Commission into Victoria's Mental Health System.

In this time of change, it is important for us at Mind to reiterate our promise to the community to provide services that people need to recover and have a better life. We continue to draw on our depth of experience to identify and address positive opportunities for our staff to meet the needs and choices of our clients under this major social reform.

This year we achieved significant expansion in Queensland. This includes an innovative holistic recovery support model in the Cairns region, comprising a Community Care Unit, an Adult Step Up Step Down service and in-community and group support services. A similar model will roll out in Mackay. Mind is also providing recovery support in two new Youth Step Up Step Down services in Brisbane and consolidating our position in NDIS service delivery with our specialised complex care and dual disability team.

In Victoria, we have begun an ambitious program of building new supported residences. Last year, we opened the 16 unit Haven Frankston with similar residences soon to follow in Geelong and Laverton. Construction of a specialist disability residence in Bendigo - the first of a series by our subsidiary Home Base Services - is almost completed.

We are embarking on an exciting journey to measure our clients' progress towards recovery and wellbeing through the My Better Life® methodology. The holistic approach we are taking to support our clients to set goals and track their achievement of them will give us a distinctive offering compared to other support organisations.

In 40 years our mission hasn't changed. We want to continue to provide the amazing care and support that we are collectively proud of at Mind, to help people significantly impacted by mental ill health to achieve the quality of life that most people expect in Australia. This involves change, imagination, investment and the commitment of our highly valued Mind team.

We look to the future of Mind and know we are doing all the right things to ensure we continue to have a huge positive impact for many more decades to come.





Our financial performance

The Mind Group recorded a surplus of \$3,592,800 for the financial year ended 30 June 2019.

This surplus includes a one off gain of \$5,886,774 resulting from our assumption of control of The Haven Foundation.

Mind's total income increased due to further expansion in Queensland and Victoria, as a result of securing additional contracts in sub-acute services.

Mind continued to transition clients into NDIS services including Supported Independent Living Services for residential clients and fee for service work.
